

Coalition to End Wildlife Trafficking Online: 2024 Progress Update



As the world comes together to achieve the ambitious target to conserve 30% of lands, waters, and oceans by 2030, global tech companies are uniting to protect biodiversity from online threats. Wildlife trafficking is the second greatest threat to biodiversity and has moved exponentially online. Behind viral videos and trending hashtags lies a devastating illicit trade in species like pangolins, big cats, primates, and birds. In demand as exotic pets to spruce up a social feed, or for fashion, decor, food, and medicine, thousands of species are threatened by wildlife trafficking.

Fortunately, the companies behind the world's most popular digital apps and platforms have rallied alongside conservation organizations WWF, TRAFFIC, and IFAW through a coalition approach. Since our last progress update in 2021, companies have blocked an additional 12.5 million sales and accounts for prohibited wildlife, bringing the total since 2018 to 24.1 million. 4,000+ search terms shared with companies + law enforcement to enhance automated detection

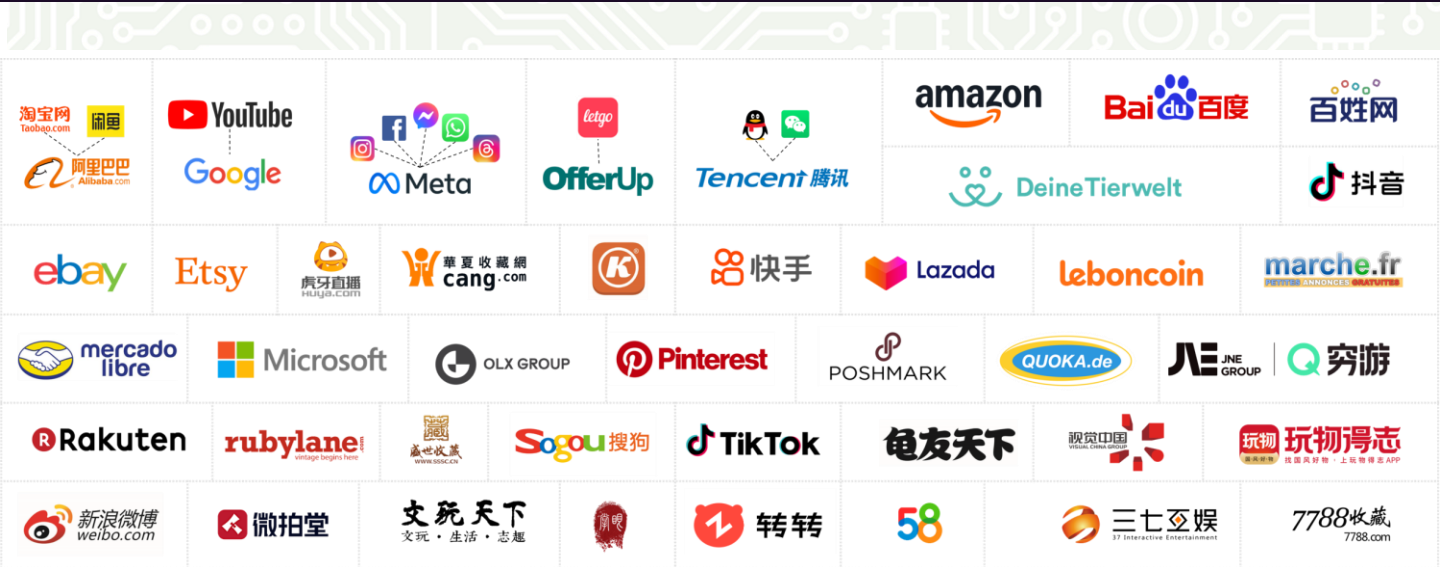
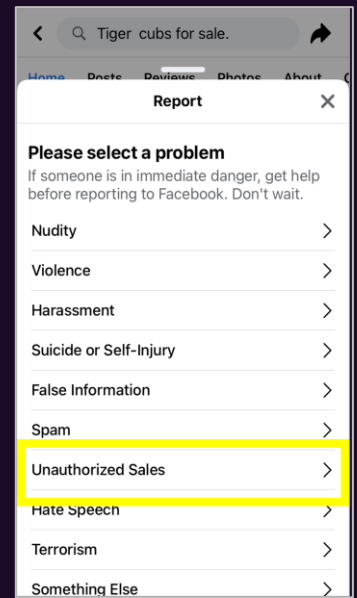
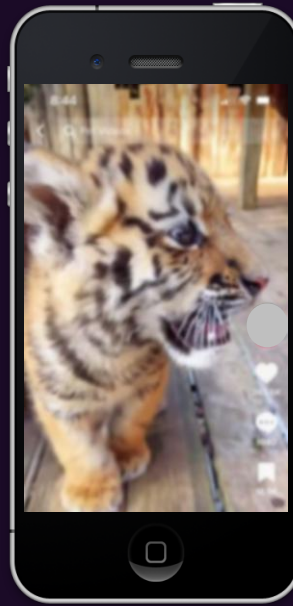

The Coalition to End Wildlife Trafficking Online launched in 2018 with conservation convenors WWF, TRAFFIC, and IFAW. This collaboration aims to unite the tech industry to standardize prohibited wildlife policies, train staff to better detect prohibited wildlife, enhance automated detection filters, and educate and empower users to report suspicious listings. At the core of this effort is sharing learning and best practices to avoid duplication and prevent wildlife traffickers from shifting activities from one platform to the next. The Coalition aims to complement additional approaches, such as those of law enforcement agencies.
